



# **Project Update**

Following the January 4, 2022 public hearing, and several deliberation sessions, the Springfield Planning Commission and Lane County Planning Commission have recommended approval of the proposed Phase 1 and Phase 2 Springfield Development Code amendments. The proposed code amendments will now move onto the Springfield City Council and Lane County Board of Count Commissioners for their consideration.
