METHODS FOR PUBLIC COMMENT

Citizen comments are normally scheduled under the agenda item "Business from the Audience" and are limited to three (3) minutes each. Multiple options will be provided for the public to ask questions and comment on the budget. Below are the methods which will be provided.

1.) Using ZoomWebinar participation functionality

ZoomWebinar software provides functionality for the organizer to allow attendees to speak during the meeting, provided the attendee is utilizing a computer or tablet with a microphone. During Business from the Audience, the meeting organizer will look for attendees to 'raise their hand' and will then unmute the attendees' microphone, allowing them to provide comment or ask a question.

2.) Written email comment in advance of the meeting
