ESSENTIAL DUTIES

- ✓ Complete and comprehensive follow-up investigation of self-initiated cases as well as assigned cases:
- ✓ Respond to any crime or Patrol Division activity at their discretion;
- ✓ Self-initiated investigation of criminal activity;
- ✓ Intelligence gathering, analysis and dissemination;
- ✓ Liaison with other agencies.
- ✓ ISB investigates the following crimes against person offenses:
 - o Homicide & death investigations;
 - Felony assaults;
 - Sexual assault;
 - o Robbery;
 - o Kidnapping;
 - Missing persons
 - o Extortion;
 - o Juvenile sex crimes;
 - o Elder abuse; and
 - o Other crimes against persons as selected by the ISB supervisor.
- ✓ Detectives investigate the following crimes against property offenses:
 - o Felony theft;
 - o Burglary;
 - o Arson;
 - o Felony vandalism;
 - o Pawn shops activities; and
 - Other property offenses as selected by the CIS supervisor.
 - o Fraud and theft by deception cases;
 - o Embezzlement;
 - o Employee theft;
 - o Tampering with drug records;
 - Computer crimes
 - Internet fraud
 - Child pornography
 - Identity Theft
 - Counterfeiting
 - Forgery
 - o Checks and credit card cases; and
 - Other cases as determined by the ISB supervisor.
