Plan review required for the following: Fire pump, Emergency system, Addition of new motor load of 100HP or more, Patient area health care facility, Hazardous locations, RV parks, 6 or more residential units, Supply over 600 volts nominal, Building over 3 stories, Service or feeder 600 amps or over, Commercial use agricultural buildings, Insallation of 150KVA or larger separately derived system, "A" "E" "I-2" "I-3" occupancy, Service or feeder 400 amps or more where the available fault current exceeds 10,000 amps at 150 volts or less to ground or exceeds 14,000 amps for all the other installations
