I was one of the leaders and also worker with the Willamette Animal Guild, Springfield Mayor and Police Department in a project that spayed/neutered 1800 Springfield cats, housed at Booth-Kelly I was president of the board of non-profit Community Veterinary Center on Hwy 99 during which What specific contribution do you hope to make?
	I would be open to several tasks, and am interested outreach for the library. I could help with an effort to get more library yard signs out if you are still doing that. Before COVID, I was involved in conversations with city staff about a display about the Kalapuya in the entrance to the library (by the vending machines), and would like to work on that display.
